Following the approval of the amendment of Prevention and Suppression of Money Laundering and Terrorist Financing Law in February 2021, the Registrar of Companies announced the implementation of a central register of Ultimate Beneficial Owners of companies and other legal entities (UBO Register) as the interim solution by the way of collection of data for Cyprus companies.

The collection of data for companies has begun on 16 March 2021 and companies will need to submit all information about its beneficial owner(s) into the relevant interim reporting system until **31 July 2022**.



DEPUTY MINISTRY OF INNOVATION PRESENTS THE WORK ON THE GOV.CY PLATFORM

The project, within the framework of the "Digital Cyprus" programme, aims to create a digital platform based on the British Gov.uk, where citizens will be able to access all public services, with ease and security.

In his speech, the Deputy Minister of Research, Innovation and Digital Policy, Kyriacos Kokkinos, said is a key-date because it is the first time that the Digital Services Factory (DSF) is presented, "a game-changing imitative", which is, he said, one of the landmark projects of Cyprus in terms of the country's digital transformation.

Kokkinos stressed that it was necessary to accelerate the country's digital capabilities to keep pace with the ongoing rapid migration to digital technologies and achieve a fast transition, at scale.

Kokkinos said that the new digital portal will host both digital public services and all governmental websites in a single domain, where people can navigate and access information and services based on life or business situations.



PAYMENT OF PENSIONS AND ALLOWANCES APRIL 2022 IN VIEW OF THE EASTER HOLIDAYS

EXTENSION OF THE DEADLINE FOR THE SUBMISSION OF INCOME TAX RETURNS FOR COMPANIES AND INDIVIDUALS

New deadline submission of 2020 Corporate Income Tax return (TD4) and Personal Income Tax return (TD1) of individuals whose annual turnover exceeds €70.000 and who have an obligation to prepare audited financial statements.

The Tax Department issued a decree extending further the deadline for submission of the above from **24 March 2022 to 31 July 2022**. announces that in view of the 2022 Easter holidays, all the necessary arrangements have been implemented for the timely payment of all pensions and allowances as bellow:

- Department of Social Integration of Persons with Disabilities by 13.4.2022.
- Monthly special pensions and benefits to the beneficiaries of the Victims Relief Fund, including the Easter Allowance by 14.4.2022.
- Pensions as well as the Special Benefit to Persons with Thalassemia of the Social Insurance Fund, the Social Pension and the Special Increase of the Institutional Pension (Honorary Allowance) by 14.4.2022.

UPCOMING DEADLINES BY APRIL 30th

• Payment of the first instalment of the premium tax for insurance companies (life business) for 2022

End of each month

- Payment of tax deducted from employees salary (PAYE) in the preceding month.
- Payment of Special Contribution for Defence (SDC) and contribution to General HealthCare System (GHS) withheld on payments of dividends, interest or rents (when the tenant is a company, partnership, the state or local authority) made to Cyprus tax residents in the preceding month.
- Payment of tax withheld in the preceding month on payments to non-Cyprus residents.
- Payment of Social insurance and contribution to General HealthCare System (GHS) deducted from employees emoluments FORM Y.K.A. 2-002.
- INTRASTAT forms are submitted to the VAT Authorities within 10 days from the end of the related month, in electronic form only provided that the supplies of a taxable person exceed the registration threshold for INTRASTAT purposes.
- The VIES form, is submitted to the VAT Authorities within 15 days from the end of the related month in electronic form only.
