

companies must pay an annual company fee at the Department of the Registrar of Companies (the "RoC") every year.

The annual company fee, as in previous years, is set at €350/company and the last day of payment is 30 June 2022.



begun on 16 March 2021 and companies will need to submit all information about its beneficial owner(s) into the relevant interim reporting system until 31 July 2022.
